

Player Registration

I hereby consent to and agree:

- That when participating in Volleyball Ireland competitions, to do so in accordance with the Rules and Regulations of Volleyball Ireland, (comprising of the Competition Rules, Constitution & Bye-Laws of Volleyball Ireland);
- To be bound by the Rules and Regulations of Volleyball Ireland, the procedures and any decisions made in accordance with the Rules and Regulations including disciplinary and anti-doping matters and the Code of Ethics & Good Practice for Children in Sport, and;
- To permit my details to be stored in a Volleyball Ireland database and to be used for Volleyball purposes.

Volleyball Ireland has joined the CEV's "Fair Play Volleyball Way" campaign, reinforcing volleyball as a clean, fair, honest, family orientated sport (see the Volleyball Ireland website for details). You are expected to abide by the rules of the game in all regards including properly imposed sanctions, and to live up to the ideals of the campaign, and by signing below, you are indicating your commitment to this policy.

It is Volleyball Ireland policy that doping is contrary to the spirit of sport and every member has a duty to ensure that the sport is free of doping. Players must complete the anti-doping program at <http://elearning.sportireland.ie> and must include your certificate as part of the registration process. If you have completed the training previously as part of your league registration, then you do not need to supply your certificate.

Coach Registration

A Volleyball Ireland Coaching License is required to be allowed to coach at Volleyball Ireland competitive matches, including National League, Cup and Championship matches.

- **All Coaches must attend a Code of Ethics Awareness Course and submit Certificate number.**
- **All Coaches (who coach junior players U18's) must complete and return a Garda Vetting Form if not previously Garda Vetted by the Volleyball Ireland.**
- If you have qualified outside the Volleyball Ireland jurisdiction, please contact the Volleyball Ireland Competitions & Development Commission.
- Coaching Registration and Licensing is only complete when the above conditions are met, and all fees paid in full.

Referee Registration

2019 Registration is valid between 1st January 2019 and 31st December 2019.

- A Referee license is required for the 1st & 2nd referee at all Volleyball Ireland National League games, Cup and Championship games.
- If you have qualified outside of Volleyball Ireland's jurisdiction, please send documentation of your qualifications to the Competitions and Development Commission.
- All Referees must complete a Safeguarding 1 Child Welfare & Protection Basic Awareness course and provide the certificate number.
- All Referees are required to be Garda Vetted by Volleyball Ireland.
- Volleyball Ireland have a strict Anti-Doping policy, and all Referees are expected to be aware of the rules, and to notify Volleyball Ireland's Anti-Doping Officer (Jessie Carmody – jessie@volleyballireland.com) if any breaches are suspected, on a confidential basis.
